ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 11-L in the area bounded by

West Agatite Avenue; The public alley west of North Milwaukee Avenue; the east west alley south of and parallel to West Agatite Avenue; A line 150 feet west of North Milwaukee Avenue (as measured along the south line of West Agatitve Avenue).

to those of a RM-4.5 Residential Multi-Unit District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
