ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 9-L in the area bounded by

The public alley next north of and parallel to West Dakin Street; a line 279.14 feet west of and parallel to North Lamon Avenue; a line 139.13 feet north of and parallel to West Dakin Street; North Lamon Avenue; West Dakin Street; North Lavergne Avenue,

to those of a Cl-1 Neighborhood Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
