ORDINANCE

1250 NORTH PAULINA CONDOMINIUM ASSOCIATION Acct. No. 363771 -1 Permit No. 1124348

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to 1250 NORTH PAULINA CONDOMINIUM ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, six (6) Balcony(s) projecting over the public right-of-way adjacent to its premises known as 1250 N. Paulina St..

Said Balcony(s) at N. Paulina measure(s):

One (1) at six point seven five (6.75) feet in length, and two (2) feet in width for a total of thirteen point five (13.5) square feet.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1124348 herein granted the sum of four hundred fifty (\$450.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
