ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 9H in an area bound by

North Leavitt Street, West Addison Street, a line 23.60 feet East of and parallel to North Leavitt Street, the alley next South and parallel to West Addison Street

to those of a CI-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.
