A line 48 feet West of and parallel to North Seeley Avenue, the alley next North of and parallel to West Roscoe Street, a line 24 feet West of and parallel to North Seeley Avenue, West Roscoe Street.

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
