ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

changing all the R.S3 Residential Single-Unit (Detached House) District symbols and indications as shown on

Map No. 1-H in the area bounded by

the alley next north of and parallel to West Race Avenue; a line 240 feet west of and parallel to North Wood Street; West Race Street; and a line 264 feet west of and parallel to North Wood Street,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses

district is hereby established in the area above described.

SECTION2. This ordinance shall be in force and effect from and after its passage and due publication.


Proposed Zoning: RT-4 Residential Two-Flat, Townhouse, and Multi-Unit District Lot Area:

2,164.34 square feet

Proposed Land Use: The Applicants are seeking a zoning change in order to permit the construction of a new three-story single family residence, with a detached two-car garage, at the subject site. The new proposed (frame) building will be masonry in construction, with limestone and hardy board accents, and measure approximately 33 feet-6 inches in height.

- A. The Project's Floor Area Ratio: 2,500.00 square feet (1.16 FAR)
- B. The Project's Density (Lot Area Per Dwelling Unit): 1 dwelling unit (2,164.34 square feet per unit)
- C. The amount of off-street parking: 2 spaces
- D. Setbacks: a. Front Setback: 7 feet-5 inches
 - b. Rear Setback: 30 feet-5 inches
 - c. Side Setbacks: East: 2 feet-6 inches West: 3 feet-0 inches
- E. Building Height: 33 feet-6 inches
