ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-2, Community Shopping District symbols as shown on Map No. 9-H in the area bounded by:

A line 100 feet North of and parallel to West Cornelia Avenue; the public alley next East of and parallel to North Hermitage Avenue; West Cornelia Avenue; North Lincoln Avenue; North Hermitage Avenue.

To those of a CI-3, Neighborhood Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.
