ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Cl-1, Neighborhood Commercial District symbols as shown on Map No. 7-N in the area bounded by:

A line 247.50 feet North of and parallel to West Diversey Avenue; a line 234.57 feet East of and parallel to North Natoma Avenue; a line 141 feet North of and parallel to West Diversey Avenue; North Natoma Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
