Please be advised that responsive to authority contained in an ordinance (the "Ordinance") adopted by the City Council (the "City Council") of the City of Chicago (the "City") on December 13, 2006, as amended by ordinances adopted on May 12, 210 and July 28, 2010, providing for the issuance of the City of Chicago \$150,115,000 General Obligation Bonds Series 2010 (Modern Schools Across Chicago Program) (the "Bonds"), on August 26, 2010 the Chief Financial Officer of the City filed that certain Notification of Sale with respect to the Bonds (the "Notification of Sale") in the office of the City Clerk of the City of Chicago. A debt service payment schedule for the Bonds (the "Debt Service Payment Schedule") was attached to the Notification of Sale as Schedule II thereto. Pursuant to Section 12 of the Ordinance the Debt Service Payment Schedule is hereby amended by deleting it in its entirety the page captioned "ALLOCATED DEBT SERVICE PAYMENT SCHEDULE PRIETO ELEMENTARY SCHOOL-GALEWOOD/ARM1TAGE REDEVELOPMENT PROJECT AREA" and replacing it with the page attached hereto. The undersigned have determined that the foregoing amendment is in the best interest of the City. Except with respect to the foregoing amendment, the Notification of Sale (including but not limited to the remainder of Schedule II thereto) remains in full force and effect as originally filed.






