ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Neighborhood Shopping District symbols and indications as shown on Map No. 20-G in an area bound by

South Loomis Street, West 87th Street, a line 58 feet East of and parallel to South Loomis Street, the public alley next South and parallel to West 87th Street

to those of a Cl-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and due publication.
