### ORDINANCE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.**

**Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District and a B3-3, Community Shopping District symbols, as shown on Map No. 5-1 in the area bounded by:**

**A line 125 feet North of and parallel to West Armitage Avenue; the public alley next East of and parallel to North Whipple Street; West Armitage Avenue; a line 50 feet East of and parallel to North Whipple Street.**

**To those of a B3-2, Community Shopping District**

**SECTION 2. This Ordinance takes effect after its passage and due publication. Common address**
