#### **ORDINANCE**

## FHML FOR PUBLICATION

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1: That the Chicago Zoning Ordinance be amended by changing all M3-3 Heavy Industry District symbols and designations as shown on Map No. 26-E in the area bounded by

a line 126 feet South of and parallel to East 108<sup>th</sup> Street; a line perpendicular to the previously described line beginning at a point 308.22 feet West of the West line of South Cottage Grove Avenue extending South to a point 552.77 feet South of East 108<sup>th</sup> Street; a line 678.77 feet South of and parallel to East 108<sup>th</sup> Street: a line perpendicular to the previously described line beginning at <f a point 27.00 feet West ofthe previously described line extending South for a distance of 109.72 feet to a point 788.49 feet South of East 108<sup>th</sup> Street; a curved lined line from the previously described point extending southeasterly at a radius of 295.07 feet for a distance of 192.16 feet to a point located 427.86 feet West of the West line of South Cottage Grove Avenue; a line 964.77 feet South of and parallel to East 108<sup>th</sup> Street; South Cottage Grove Avenue,

to the designation of the C3-1 Commercial, Manufacturing, and Employment District, which is hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from and after its passage and due publication.

The Applicant, Chicago Collegiate Charter School, is seeking approval to temporarily re-locate its school, which is located at 11816 S. Indiana Avenue into 18,300 SF of the existing Salem Baptist Church. The existing Church will remain. The Church currently has 141 parking spaces, which will also remain. The site is located within an industrial corridor and as such will need to be reviewed by the Chicago Plan Commission. The Applicant is seeking approval to rezone the property from the M3-3 to the C3-1 and then obtain a special use in order to allow the church use to remain and to allow the school use.
