### **ORDER**

WHEREAS, Section 2-120-815 of tile Municipal Code provides that the Chicago City Couiidi may by passage of an appropriate order waive any fees charged by the City for any permit for which approval of the Commission on Chicago Landmarks (the "Commission") is required, in accordance with chapter 2-120 of the Municipal Code: and

### BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:
