ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City Council of the City (the "City Council") has determined that the continuance of a shortage of rental housing affordable to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City programmed HOME Investment Partnership Program ("HOME") funds whereby acquisition and rehabilitation loans were made available to owners of rental properties, and HOME is administered by the City's Department of Planning and Development ("DPD"); and

WHEREAS, the City Council, pursuant to an ordinance enacted on September 15, 1993, and published at pages 37366-37370 of the Journal of the Proceedings of the City Council (the "Journal of Proceedings") of that date, authorized DPD to provide HOME financing in the amount of \$2,069,601 (the "Johnson Loan") for the rehabilitation of a building called the Eddie Mae & Alex Johnson Apartments (the "Johnson Apartment Building") located at 6230 South Dorchester Avenue, in Chicago, Illinois, and the 64 residential dwelling units therein (the "Johnson Project"); and

WHEREAS, Woodlawn East Community and Neighbors, Inc., an Illinois not-for-profit corporation (the "Borrower"), owns the Johnson Apartment Building; and

WHEREAS, in connection with the Johnson Project, the City made the Johnson Loan to the Borrower on December 14, 1993 with an interest rate of zero percent per annum, which Johnson Loan is secured by, among other things, that certain Junior Mortgage and Security Agreement dated December 14, 1993 and recorded on December 14, 1993 in the Office of the Recorder of Deeds of Cook County, Illinois as document number 03023732, made by the Borrower in favor of the City (the "Johnson Mortgage"); and

WHEREAS, the City Council, pursuant to an ordinance enacted on February 10, 1999, and published at pages 88931-88938 of the Journal of the Proceedings of that date, authorized DPD to provide HOME financing in the amount of \$3,664,974 (the "Butler-Lindon Loan," and collectively with the Johnson Loan, the "Loans") for the rehabilitation of a building called the Butler-Lindon Apartments (the "Butler Apartment Building," and collectively with the Johnson Apartment Building, the "Buildings") located at 6146 South Kenwood Avenue, in Chicago, Illinois, and the 42 residential dwelling units therein (the "Butler-Lindon Project"); and

WHEREAS, the Borrower owns the Butler Apartment Building; and

WHEREAS, in connection with the Butler-Lindon Project, the City made the Butler-Lindon Loan to the Borrower on December 16, 1999 with an interest rate of zero percent per annum, which Butler-Lindon Loan is secured by, among other things, that certain Junior Mortgage, Security Agreement and Financing Statement dated December 16, 1999 and

recorded on December 16, 1999 in the Office of the Recorder of Deeds of Cook County, Illinois as document number 09170959, made by the Borrower in favor of the City (the "Butler-Lindon Mortgage," and collectively with the Johnson Mortgage, the "Mortgages"); and

WHEREAS, the Borrower wishes to sell the Buildings to POAH JBL LLC ("JBL"), an Illinois limited liability company, the sole member of which is Preservation of Affordable Housing, Inc., which is an Illinois not-for-profit corporation, and requested that DPD approve the proposed sale of the Buildings and assumption of the Mortgages and other associated Loan documents by JBL (the "Transfer"); and

WHEREAS, DPD has approved a restructuring of the Loans (the "Restructuring") in a manner which (1) will authorize the Transfer, (2) will not alter the principal amount of the Loans, (3) will not alter the interest rate on the principal balance of the Loans, (4) will not alter the maturity date of the Loans, and (5) once the Transfer is complete, there will not be any liens superior in priority to the City's liens (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of DPD (the "Commissioner") or a designee of the Commissioner, are each hereby authorized, subject to approval by the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Restructuring which do not substantially modify the Material Terms of the documents for the Loans, except as indicated herein. The Commissioner, or a designee of the Commissioner, are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Restructuring. The Commissioner or a designee of the Commissioner are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with any future restructuring of the Loans, which do not substantially modify the Material Terms of the Loans.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance. Sections 2-45-110 and 2-45-115 of the Municipal Code of Chicago shall not apply to the Buildings in connection with the Restructuring.

SECTION 4. This ordinance shall be effective as of the date of its passage and approval.
