ORDINANCE PRAXAIR INC Acct. No. 2099 -1 Permit No. 1127933

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PRAXAIR INC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Pipe Line(s) under the public right-of-way adjacent to its premises known as 13400 S. Avenue O.

Said Pipe Line(s) at S. 130 to 135 Street Ave O/S. Green Bay & Burley measure(s):

One (1) at eight hundred eighty-two (882) feet in length, and one point three three (1.33) foot in width for a total of one thousand one hundred seventy-three point zero six (1173.06) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Office of Underground Coordination), and Department of Water Management.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1127933 herein granted the sum of five thousand two hundred ninety-two (\$5,292.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private proc/erty/caused by the City performing work in the public way. Alderman
