ORDINANCE
AMERICAN DENTAL ASSOCIATION Acct. No. 11494-1 Permit No. 1128348

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to AMERICAN DENTAL ASSOCIATION, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Canopy(s) projecting over the public right-of-way adjacent to its premises known as 211 E. Chicago Ave..

Said Canopy(s) at E. Chicago Avenue measure(s):

One (1) at sixty-eight point eight (68.8) feet in length, and ten point eight (10.8) feet in width for a total of seven hundred forty-three point zero four (743.04) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1128348 herein granted the sum of ninety -three dollars and eighty cents (\$93.80) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after£5/23/2017.
