BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO: SECTION 1. Title

17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the

RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map

No. 1 -G in the area bounded by

a line 150 feet south of and parallel to West Ohio Avenue; the alley next east of  
and parallel to North Bishop Street; the alley next south of and parallel to West  
Ohio Street; and North Bishop Street,

to those of a RM4.5 Residential Multi-Unit District and a corresponding use district is hereby  
established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due  
publication.
