ORDINANCE

BE IT ORDAINED BY CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No.18-E in the area bounded by

a line from a point 126.16 feet west of South Vernon Avenue along East 75th Street;

the public alley north of East 75th Street; South Vernon Avenue and East 75th Street,

to those of a C1-2 Neighborhood Commercial District and corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
