ORDINANCE

IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Ml-1 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 5-H in the area bounded by

North Milwaukee Avenue; a line 330.00 feet north of and parallel to the north line of West Moffat Street; the alley next southwest of and parallel to Milwaukee Avenue; and a line 396.00 feet north of and parallel to the north line of West Moffat Street

to those of a B3-3 Community Shopping District.

SECTION 2. This ordinance shall Toe in force and effect from and after its passage and due publication.

COMMUNITY SHOPPING DISTRICT LOT AREA: 6,600 SQUARE FEET

LAND USE: THE PROPERTY IS CURRENTLY IMPROVED WITH A ONE-STORY BRICK AND CONCRETE BLOCK BUILDING. THE PROPERTY WILL BE REDEVELOPED TO PROVIDE FOR A SIX-STORY BRICK BUILDING WITH 27 DWELLING UNITS IN TOTAL ALL LOCATED ABOVE THE GROUND FLOOR AS FOLLOWS: SIX (6) UNITS EACH ON THE SECOND, THIRD, FOURTH, AND FIFTH FLOORS, AND THREE (3)

UNITS ON THE SIXTH FLOOR. APPLICANT IS USING SECTION 17-10-0102-B OF THE CHICAGO ZONING ORDINANCE TO REDUCE A PARKING REQUIREMENT FOR THE BUILDING TO RESULT IN FIVE (5) PARKING SPACES LOCATED ON SITE. APPLICANT WILL SEEK A VARIATION OF THE CHICAGO ZONING ORDINANCE TO REMOVE AN OFF-STREET LOADING REQUIREMENT.



In accordance with the requirements for an amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about November 1, 2017, the undersigned intends to file an application for a change in zoning for the properly with an address range of 1892-1900 North Milwaukee Avenue (the "Property") from Ml-1 Limited Manufacturing/Business Park District to B3-3 Community Shopping District.

The property is currently improved with a one-story brick and concrete block building. The applicant is seeking to rezone the property to provide for a six-story brick building with one (1) commercial unit on the ground floor, and twenty seven (27) dwelling units in total all located above the ground floor as follows: six (6) units each on the second, third, fourth and fifth floors, and three (3) units on the sixth floor. The property is within 1,320 feet of a CTA rail station entrance and will provide no more than one (1) parking space per dwelling unit, satisfy all parking reductions for transit-served locations and provide 100% of the required affordable units on-site, and as a result parking will be reduced to result in five (5) parking spaces on site and the height of the new building will be 70 feet 0 inches. The applicant will seek a variation to remove an off-street loading requirement.
