## **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Bl-2, Neighborhood Shopping District symbols as shown on Map No. 10-E in the area bounded by:

East 45<sup>th</sup> Street; South St. Lawrence Avenue; a line 62.50 feet South of and parallel to East 45th Street; the public alley next West of and parallel to South St. Lawrence Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District


