SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

changing all the RS3 Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-1

in the area bounded by

West Rice Street; a line 175 feet east of and parallel to North Washtenaw Avenue; the alley next south of and parallel to West Rice Street; and a line 150 feet east of and parallel to North Washtenaw Avenue,

to those of a RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses

district is hereby established in the area above described.
