ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Planned Development Number 1355 District symbols as shown on Map No. 6-F, in the area bounded by:

The public alley next North of and parallel to West 22nd Place; a line 250.56 feet East of and parallel to South Princeton Avenue; West 22nd Place; a line 75 feet East of and parallel to South Princeton Avenue.

To those of a B3-5, Community Shopping District

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
