ORDINANCE 116-120 Chestnut Properties LLC Acct No 375201 - 1 Permit No. 1130530

Be It Ordained by the City Council of the City of Chicago-

SECTION 1 Permission and authority are hereby given and granted to 116-120 Chestnut Properties LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 116-120 W Chestnut St

Said Occupation of Space(s) at W Chestnut St measure(s):

One (1) at fifteen point five (15.5) feet in length, and three point three three (3.33) feet in width for a total of fifty-one point six two (51.62) square feet.

One (1) at fifteen point one seven (15.17) feet in length, and three (3) feet in width for a total of forty-five point five one (45 51)square feet

The location of said privilege shall be as shown on prints kept on file-with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination)

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago

The grantee shall pay to the City of Chicago as compensation for the privilege #1130530 herein granted the sum of eight hundred fourteen (S814.00) per annum in advance


A 25% penalty will be added for payments received after due date

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way

Authority herein given and granted for a period of five (5) years from and after 12/12/2017.
