### ORDINANCE

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District, as shown on Map 4-H in the area bounded by:

**West Cullerton Street, a line 120 feet West of South Paulina Street, the alley next south of and parallel to West Cullerton Street and a line 144 feet West of South Paulina Street, except a triangle at the northwest corner of said parcel 7.0 feet by 10 feet in size, the hypotenuse of said triangle being 12.20 feet.**

#### **To those of B2-3 Neighborhood Mixed-Use District**

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
