ORDINANCE

#E / J ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No 11 -G in the area bounded by

West Lawrence Avenue; the alley next east of and parallel to North Ashland Avenue; a line 156.11 feet south of and parallel to West Lawrence Avenue; and North Ashland Avenue,

to those of a B3-3 Community Shopping District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

The Applicant is seeking a zoning change in order to permit the construction of a new four-story mixed-use (commercial/residential) building, at the subject property.
