ORDINANCE

SOCIALE AND CAFE PRESS Acct. No.
396907 -1 Permit No. 1132547

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to SOCIALE AND CAFE PRESS upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 800 S. Clark St.. Said sidewalk cafe area #1 shall be sixty-nine point four six (69.46) feet in length and seven point five eight (7.58) feet in width, area #2 shall be twenty-five point six (25.6) feet in length and seven point seven five (7.75) feet in width for a total of seven hundred twenty-four point nine one (724.91) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along S. Clark. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Monday - Sunday 8:00 am to 12:00 am
Compensation: \$1,304.83 SEATING CAPACITY: 40

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1132547 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 through 10-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused-by the City performing work in the public way.

Authority for the above named privilege is herein given and granted from and after March 1, Alderman
2018 through and including December 1, 2018.
