ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Bl-2 Neighborhood Shopping District symbols and indications as shown on Map No. 3-H in an area bound by

The alley next West of and parallel to North Ashland Avenue; a line 65 feet South of and parallel to West Pearson Street; North Ashland Avenue; a line 115 feet South of and parallel to West Pearson Street

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.
