### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS 3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 18-C in an area bound by

The alley next West of and parallel to South Chappel Avenue, a line 78 feet South of and parallel to East 77<sup>th</sup> Street; South Chappel Avenue; a line 109 feet South of and parallel to East 77<sup>th</sup> Street

to those of an RT 3.5 Residential Two-Flat, Townhouse and Multi-Unit District.
