ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 7-G in an area bound by

A line 186 feet West of and parallel to North Racine Avenue; the alley next North of and parallel to West George Street; a line 161 feet West of and parallel to North Racine Avenue; West George Street

to those of an RT4 Residential two-Flat, Townhouse and Multiple Unit District.

SECTION 2. This ordinance takes effect after its passage and due publication.
