ORDINANCE

/r ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District and Cl-2 Neighborhood Commercial District symbols and indications as shown on Map No.3-G in the area bounded by

West Augusta Boulevard; a line 175 feet east of and parallel to North Noble Street; the alley next south of and parallel to West Augusta Boulevard; and a line 25 feet east of and parallel to North Noble Street,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


