ORDINANCE  
THE UNIVERSITY OF CHICAGO Acct. No.  
43697-115 Permit No. 1134206

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to THE UNIVERSITY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, two (2) Park bench(s) on the public right-of-way adjacent to its premises known as 1135 E. 57th St..

Said Park bench(s) at E. 57th Street measure(s):

Two (2) at six (6) feet in length, and one point six seven (1.67) foot in width for a total of twenty point zero four (20.04) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1134206 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
