### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current B3-2 Community Shopping District symbols and indications as shown on Map No. 6-1 in the area bounded by:

A line 48.69 feet north of West 23<sup>rd</sup> Place; the public alley next east of South California Avenue; West 23<sup>rd</sup> Place; and South California Avenue

to those of a RM5.5 Residential Multi-Unit District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
