# ORDINANCE

WHEREAS, the City of Chicago (the "City"), is a home rule unit of government under Article VII, Section 6(a) of the Constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the Board of Education of the City of Chicago (the "Board"), is a body corporate

and politic, created pursuant to Article 34 of the School Code of the State of Illinois, 105 ILCS 5/1-1, et seq. (the "School Code"); and

WHEREAS, the Board is the beneficial owner of the real estate located at 7025, 7004 and 7034 S. Princeton Avenue, Chicago, the former Yale Elementary School as legally described on Exhibit A attached hereto (the "Property"); and

WHEREAS, title to 7025 S. Princeton, PIN: 20-21-421-023 ("Parcel A") is currently held by the Public Building Commission of Chicago for the Board, and title to 7004 and 7034 S. Princeton, PINS: 20-21-420-047 and 20-21-420-031 ("Parcel B") is held by the City, as Trustee, in Trust for the Use of Schools; and

WHEREAS, Parcel B is located adjacent to the former Yale Elementary School and constitutes a portion of Property; and

WHEREAS, pursuant to Section 34-21 (b)(1) of the School Code, by vote of no less than twothirds (2/3) of its full membership, the Board determined that the Property has become unnecessary, unsuitable, and unprofitable for use as a school or for the purposes of school administration, and that the sale of the Property constitutes the best available use of such real estate for the purpose of deriving revenue to support the Board's authorized purposes; and

WHEREAS, the Board advertised the Property for sale and received two bids for the Property, which were opened in the Board's Department of Procurement and Contracts on May 14, 2018, the bid closing date; and

WHEREAS, VLV Development and Financial Services, Corp. ("VLV") on behalf of Climate Leadership Innovation Center, LLC ("CLIC") submitted the highest offer to acquire the Property in the amount of Sixty-Five Thousand Dollars and No/100 Dollars (\$65,000) (the "Purchase Price"); and

WHEREAS, CLIC's proposed plan is to use and convert the former Yale School to a clean energy demonstration and manufacturing/logistics and training facility for solar wind, solar thermo and battery production and storage and administrative and business offices training and development programs; and

WHEREAS, the Board obtained the following disposition appraisal for the entire Property including Parcel B as of April 1, 2018:

Appraiser: KMD Valuation Group, LLC Disposition Value: \$50,000 to \$100,000; and

WHEREAS, the disposition appraisal takes into consideration the Use Restrictions (as hereinafter defined); and

WHEREAS, on August 22, 2018, the Board, pursuant to Resolution Number 18-0822-OP4 (the "Resolution"), voted by more than two-thirds of his membership to accept VLV's bid in the amount of the Purchase Price, for the entire Property, including Parcel B; and

WHEREAS, the Resolution includes a request to the City to convey Parcel B to Climate Leadership Innovation Center, LLC in accordance with Section 34-21 (d)(1) of the School Code subject to the conditions that the Property may not be used as a K-12 charter school and that the Grantee must obtain a Certificate of Occupancy from the City for the former school building within four (4) years from the date of the deed (collectively, the "Use Restrictions"); now, therefore,

# BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

Section 1. The foregoing recitals are hereby adopted as the findings of the City Council.

Section 2. The City of Chicago hereby accepts VLV's bid to purchase the Property, including Parcel B, described on Exhibit A in the amount of the Purchase Price.

Section 3. The Mayor or his proxy is authorized to execute and the City Clerk or the Deputy City Clerk is authorized to attest, a quit claim deed conveying to CLIC all right, title and interest of the City, as Trustee, in Trust for the Use of Schools, in and to Parcel B, subject to the Use Restrictions in substantially the following form:

THE PROPERTY MAY NOT BE USED AS A K-12 CHARTER SCHOOL. TITLE TO THE PROPERTY WILL REVERT BACK TO THE CITY OF CHICAGO, IN TRUST FOR USE OF SCHOOLS, AS LEGAL TITLE HOLDER OF RECORD FOR THE BENEFIT OF THE BOARD IF THIS RESTRICTION IS BREACHED WITHOUT THE PRIOR WRITTEN APPROVAL OF THE BOARD'S CHIEF OPERATING OFFICER, OR CHIEF ADMINISTRATIVE OFFICER, OR IF. GRANTEE FAILS TO OBTAIN A CERTIFICATE OF OCCUPANCY FROM THE CITY OF CHICAGO FOR THE PROPERTY WITHIN FOUR YEARS OF THE DATE OF THE DEED.

Section 4. The interest of the City, as Trustee, in Trust for the Use of Schools, in and to Parcel B shall be conveyed in its "AS IS-WHERE IS" condition, and the deed conveying such interest shall provide that the City and the Board are to be released and discharged from any and all responsibility or liability with respect to the Property's physical, structural and environmental condition.

Section 5. The Mayor, the City Clerk, and the Commissioner of the Department of Fleet and Facility Management (the "Commissioner"), or a designee of the Commissioner, are each authorized to execute and deliver on behalf of the City such supporting documents and certificates and to do such other things consistent with the terms of this Ordinance as such officers and employees shall deem necessary or appropriate in order to implement the provisions of this Ordinance.

Section 6. If any provision of this Ordinance shall be held to be invalid or unenforceable for any

reason, the invalidity or unenforceability of such provision shall not affect any of the other provisions of this Ordinance.

Section 7. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 8. This Ordinance shall take effect upon its passage and approval.
