ORDINANCE

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the MI-2, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 20-C in an area bound by

A line 849.4 feet west of and parallel to South East End Avenue; South South Chicago Avenue; a line 525 feet west of and parallel to South East End Avenue; and the public alley next southwest of and parallel to South South Chicago Avenue

to those of a M3-2, Heavy Industry District.

SECTION 2. This ordinance takes effect after its passage and due publication.
