TRAFFIC LANE - TOW ZONES

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

WARD	TOW ZONES:
4	South Rhodes Avenue (west side) from a point 75 feet south of East 35th Street to a point 50 feet south thereof; No Parking Tow Zone, All Times, All Days, Public Benefit [02018-5359]
29	North Austin Boulevard (east side) from West Chicago Avenue south to the first alley; No Parking Tow Zone, 7:00am to 9:00am and 4:00pm to 6:00pm, Monday through Friday and Also North Austin Boulevard (east side) from West Augusta Avenue south to the first alley; No Parking Tow Zone, All Times, All Days [02018-8890]
42	East South Water Street (north side) from a point 28 feet west of North Field Boulevard to a point 76 feet west thereof; No Parking Tow Zone, 6;00pm to 7:00am, Monday through Friday, All Times, Saturday through Sunday, Public Benefit - (18-01738596) [02018-4143]
