ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-K in the area bounded by

A Line 216 Feet South of and parallel to West Armitage Avenue; North Kenneth Avenue; A Line 241 Feet South of and parallel to West Armitage Avenue; The Alley next West of and parallel to North Kenneth Avenue.

to those of a RT-4, Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
