#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4, Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map No. 10-E in the area bounded by

A line 290.33 feet South of and parallel to West 43<sup>rd</sup> Street; South Langley Avenue; a line 310.12 feet South of and parallel to West 43<sup>rd</sup> Street; the public alley next West of and parallel to South Langley Avenue.

to those of a RM-4.5, Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
