### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 4-H in the area bounded by

West 21<sup>st</sup> Street; a line 200.00 feet west of and parallel to South Paulina Street; the public alley next south of and parallel to West 21<sup>st</sup> Street; a line 225.00 feet west of and parallel to South Paulina Street

to those of RM-5 Residential Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
