ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the Bl-1 Neighborhood Shopping District symbols and indications as shown on Map No.10-1 in the area bounded by

a line 'l 98.50 feet south of and parallel to West 43rd Street; South California Avenue; a line 248.50 feet south of and parallel to West 43rd Street; and the alley next west of and parallel to South California Avenue,

to those of a B2-1 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


