ORDINANCE
GRANADOS SUPERMERCADO Acct. No.
308893 - 1 Permit No. 1135378

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GRANADOS SUPERMERCADO, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1855 W. 47th St..

Said Awning(s) at W 47th St measure(s):

One (1) at sixty point seven five (60.75) feet in length, and two point four one (2.41) feet in width for a total of one hundred forty-six point four one (146.41) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1135378 herein granted the sum of eighty-five dollars and seventy-five cents (\$85.75) per annum in advance.

A 25% penalty will be added for payments received after due date.
