# fl£ JT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICA GO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

changing all the CI-2 Neighborhood Commercial District symbols and indications as shown on Map No. 3-H in

the area bounded by

West North Avenue; a line 219 feet west of and parallel to North Paulina Street; the alley next south of and parallel to West North Avenue; and a line 243 feet west of and parallel to North Paulina Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about January 11, 2019,1, the undersigned, intend to file an application for a change in zoning from a CI-2 Neighborhood Commercial District to a B2-3 Neighbor Mixed-Use District, on behalf of the Applicant/Owner - 1723 W North Ave LLC, for the property located at 1723 West North Avenue, Chicago, Illinois.

The Applicant is seeking a zoning change in order to permit the preservation and rehabilitation of the existing two-story mixed-use building, at the subject site. The rehabilitation plan calls for the erection of a two-story ( $3^{rd}$  Floor and  $4^{th}$  Floor) vertical addition, above the existing  $2^{nd}$  Floor. The rehabilitation plan also calls for the conversion of the existing mixed-use building to an all-residential use, to allow for the establishment of four (4) dwelling units within the newly rehabilitated building.
