BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

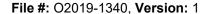
SECTION 1: That the Chicago Zoning Ordinance be amended by changing all RM-5 Residential Multi-Unit District symbols and indications as shown on Map No. 10-D in the area bounded by

a line 260.00 feet north of and parallel to East 47th Street; South Drexel Boulevard, East 47th Street; the alley next west of and parallel to South Drexel Boulevard;

to those of the Bl-1 Neighborhood Shopping District and a corresponding use districHs hereby established in the area above described.

SECTION 2: This Ordinance shall be in force and effect from and after its passage and due publication.

They seek a zoning map amendment to change the zoning district from RM-5 Zoning District to Bl-1. The applicant intends to use the subject property as a physical fitness center, renovating the existing 12,000 square foot building with a building height of approximately 14 feet. The current zoning district for this property does not allow the proposed use. 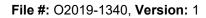
