SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by

Map No. 3-H in the area bounded by

A line 275 feet south of and parallel to West Hirsch Street; North Leavitt Street; a line 299.7 feet south of and parallel to West Hirsch Street; and the alley next west of and parallel to North Leavitt Street,

to those of a RT3.5 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding uses

district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


