SUBDIVISION ORDINANCE

Be it Ordained by the City Council of the City of Chicago:

SECTION 1. The Commissioner of the Chicago Department of Transportation, or any of her designees, is each hereby authorized and directed to approve a proposed Pulaski Promenade Subdivision, being a resubdivision of certain lots owned by Pulaski Promenade LLC, a Delaware limited liability company ("Developer"), in the block bounded by W. 40th Street, S. Pulaski Road, S. Karlov Avenue and W. Ann Lurie Place (AKA W. District Boulevard), and legally described in the attached plat (Exhibit A, CDOT File: 03-14-18-3867) which, for greater certainty, is hereby made a part of this ordinance.

SECTION 2. The subdivision herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, the Developer shall file or cause to be filed for recordation with the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the full sized corresponding plat approved by the Department of Transportation's Acting Superintendent of Maps and Plats.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication. The subdivision shall take effect and be in force from and after the recording of the approved ordinance and associated plat.
