ORDINANCE SMOQUE BBQ Acct.
No. 302771 -1 Permit No. 1139435

Be It Ordained by the City Council of the City of Chicago:

Permission and authority are hereby given and granted to SMOQUE BBQ upon the terms and subject to the conditions of this ordinance, to maintain and use a portion of the public right of way for a sidewalk cafe adjacent to its premises located at 3800 N. Pulaski Rd.. Said sidewalk cafe area #1 shall be forty-four point five (44.5) feet in length and nine point five (9.5) feet in width, area #2 shall be twenty-three point five (23.5) feet in length and nine point five (9.5) feet in width for a total of six hundred forty-six (646) square feet and shall allow six (6) feet of clear space from the face of the curb/building line along West Grace. The compensation for said space and the days and hours of operation for the sidewalk cafe shall be as follows:

Sunday 11:00am until 9:00pm Monday closed Tuesday through Thursday 11:00am until 9:00pm Friday
& Saturday 11:00am until 10:00pm Compensation: \$710.60 SEATING CAPACITY: 36

Sidewalk Cafe Permit and approved plan must be posted at all times.

This grant of privilege #1139435 for a sidewalk cafe shall be subject to the provisions of Section 10-28-800 though '1T3-28-885 of the Municipal Code of Chicago and the directions of the Commissioner of Department of Business Affairs and Consumer Protection, the Commissioner of Streets and Sanitation, and the Commissioner of Transportation.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
