ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the Cl-2, Neighborhood Commercial District symbols as shown on Map No. 1-H in the area bounded by:

West Lake Street; a line 233.41 feet east of and parallel to North Western Avenue; the public alley next south of and parallel to West Lake Street; a line 130.50 feet east of and parallel to North Western Avenue.

To those of a C2-2, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.
