### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the current B2-2 Neighborhood Mixed-Use District symbols and indications as shown on Map No. 4-G in the area bounded by:

West 18<sup>th</sup> Street; the public alley next west of and parallel to South Peoria Street; the public alley next south of and parallel to West 18<sup>th</sup> Street; and a line 74.75 feet west of the alley next west of and parallel to South Peoria Street

to those of a CI-2 Neighborhood Commercial District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
