BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District symbols and indicators as shown on Map No. 1 -L in the area bounded by

The public alley next east of and parallel to North Lockwood Avenue; a line 92 feet south of and parallel to West Race Avenue; a line 125.05 feet east of and parallel to North Lockwood Avenue; a line 70 feet south of and parallel to West Race Avenue; North Lockwood Avenue; and a line 100 feet south of and parallel to West Race Avenue.

to those of a RT-3.5 Residential Two-Flat, Townhouse and Multi-Unit District.
