ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9 - H in the area bounded by:

A line 291 feet north of and parallel to West Cornelia Avenue; North Ashland Avenue; A line 266 feet north of and parallel to West Cornelia Avenue; and the alley next west and parallel to North Ashland Avenue.

to those of a CI-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 7, 2019, the undersigned will file an application for a change in zoning from BI-2, Neighborhood Shopping District to CI-2, Neighborhood Commercial District on behalf of Areta C. Placek for the property located at 3528 N. Ashland Ave., Chicago, IL 60657.

The applicant intends to use the subject property, which is an existing two-story building containing one residential dwelling unit on the second floor, and an office space with six private offices on the first floor. There are 5 offices each of approximately 110 sf on the south side of the commercial space, and a utility room which has the furnace and utility sink. There is a common area on the east side of the commercial space which is approximately 20'X25' in dimension. On the north side of the commercial space, there are two restrooms, a conference room, an office, and a kitchenette with a refrigerator and a table. This physical structure will stay the same. No construction. Square footage to remain the same. Tenant seeks to use one of the office spaces for a personal services body art micropigmentation business.
