ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM5 Residential Multi-Unit District symbols and indications as shown on Map No. 10-E in the area bounded by:

A line 50 feet south of and parallel to East 45th Street; a line 113.63 feet East of and parallel to South Indiana Ave; a line 96.0 feet South of and parallel to East 45th Street; the public alley next east of and parallel to South Indiana Ave; a line 100 feet south of and parallel to East 45th Street; and South Indiana Ave

to those of a BI-1 Neighborhood Shopping District.

Section 2. This ordinance shall be in force and effect from and after its passage and due publication.
